To the Daughters and Bethel Guardian Council:

It is with great excitement that we announce the 2020 "The Her in Hero" Miss Indiana and Jr Miss Indiana Job's Daughters Pageant, which will be held Saturday, September 5, 2020 at the Indianapolis Murat Shrine Arabian Room. The Pageant will begin at 7:00 pm.

All contestants must be active members in good standing in their Bethel, and must have completed their Proficiency Test. Miss Indiana contestants shall be at least sixteen (16) and not yet twenty (20) on the day of pageant. Jr Miss Contestants shall be at least ten (10) and not yet sixteen (16) on the day of pageant.

The Bethel Guardian must review the Indiana Pageant criteria found in the Indiana Manual of Rules and Regulations. Due to recommendations by SGC for no Bethel meetings until after August 31, 2020 contestants are not required to be voted on by their Bethel for registration to Pageant.

Pageant contestants are required to attend Pageant Preliminaries on Saturday, September 5, 2020 at 8:00am at Southport Lodge 5678 South East Street Indianapolis, IN 46227. The contestants will complete their Ritual competition, take the written examination, have their Regalia judged, and have a short interview with interview judges. Contestants will be released by 4:00pm to prepare for the Pageant.

All contestants are required to raise Sponsor and Patron monies. The contestants are asked to obtain a minimum of \$150 in Sponsors and Patrons by August 21st. Bethel members, parents and other adults can help secure these donations. Remember, these donations defray the costs of Pageant, including our Miss Indiana competing in the Miss International Job's Daughters Pageant in Hampton, Virginia in August 2021.

Sponsors and Patrons will have their names listed in the Pageant program. The plan is for Pageant to be open to Bethel, family members, friends and invited guests.

We are hoping to see at least one daughter from each Bethel represented at Pageant. Please feel free to contact us if you have any questions.

## **Bethel Guardian’s Checklist**

- ☐ Please encourage your daughters to participate in the pageant this year! Pageant is a wonderful experience and the girls make friends and memories to last a lifetime!! All events will be taking place on September 5, 2020.
- ☐ Read the communication (letter to daughters and council) at your soonest Bethel activity. Send the registration to packet out to any eligible daughters. Sign the eligibility form (can be electronic signature) for each participating contestant.
- ☐ Call the parent of each contestant and make sure they review the packet with their daughter. Make sure to remind them of the entry packet, the entry fee of \$50 due by August 1st. The required minimum Sponsor and Patron monies of \$150 due by the deadline of August 21st.
- ☐ Work with your contestant(s) to help them identify potential donors (sponsors and patrons) and be sure they are securing as many as possible.
- ☐ Miss contestants will need to be prepared to give 2nd, 3rd, or 4th Messenger. Each Miss Contestant will draw for their part. They should prepare for their written examination by studying the Ritual, Proficiency Lessons, Music Ritual and Constitution and Bylaws.
- ☐ Jr. Miss Contestants will need to be prepared to give 1st or 2nd Messenger and will need to prepare for the written examination by studying the Ritual and the Proficiency Lessons. Each contestant will draw for which messenger part they will recite.

## **Contestant Checklist**

- ☐ Review the packet with your Bethel Guardian and have her sign the entry form, verifying you are eligible to participate.
- ☐ Complete the Contestant Entry Form and Contestant Questionnaire (plus a resume for Miss IN contestants) and mail them along with your entry fee of \$50 and the completed sheets by August 1, 2020 to Jamie Yeadon 4246 Stillwater Way Plainfield, IN 46168
- ☐ Immediately begin securing Sponsor and Patrons. Remember—a minimum of \$150 is required. The daughter raising the most money will receive an award at Pageant.
- ☐ Minimum \$150 sponsors/patrons donations is due by August 21, 2020.
- ☐ **Miss contestants** will need to be prepared to give 2nd, 3rd, or 4th Messenger. Each Miss contestant will draw for which messenger part she will recite. You will give your Ritual part in your official regalia and be judged on your floor work, presentation and wording. An award for the highest Ritual score will be presented at Pageant. You should prepare for the written examination by studying the Ritual, Proficiency Lessons, Music Ritual and The Supreme Constitution/Bylaws and the Indiana Manual of Rules and Regulations.
- ☐ **Jr. Miss Contestants** will need to be prepared to give 1st or 2nd Messenger. Each Jr Miss contestant will draw for which messenger part she will recite. You will give your Ritual part in your official regalia and be judged on your floor work, presentation and wording. An award for the highest Ritual score will be presented at Pageant. You should prepare for the written examination by studying the Ritual and the Proficiency Lessons.
- ☐ Ensure that your official regalia is perfect. The cord must be sewn on, with a four to six inch opening in the front, four inch hem, and three inches from the floor. Your robe should be clean and pressed and be sure you have white shoes, white hose and a full white slip or a long half slip and camisole. Press your headband and remember you need bobby pins.
- ☐ On September 5th, you will have a personal interview with our pageant judges who will also be judging the evening portion of the pageant. They want you to be successful. Do not be intimidated and be yourself.
- ☐ The dress code for Pageant weekend will be appropriate dresses, skirt and tops or business suits.
- ☐ Remember our organization is about grace and humility. Please remember this when selecting your gown for Pageant. Please review the dress code included in this packet before you select your gown. Remember every point counts and you do not want to be counted off for inappropriate dress.
- ☐ To prepare for the interview portion of competition, you may want to engage in conversations with other adults and have them interview you.
- ☐ To prepare for the Pageant stage presentation, you should practice walking in your gown and shoes, holding your head upright, smiling and maintaining good posture.
